

LIABILITY RELEASE FORM**

I understand that the use of firearms, the use of carts and vehicles available for rental and use or use of my own vehicle, is a hazardous activity that can cause serious bodily injury and/or death.

In consideration for my being permitted to participate in the activities of the Palmetto Shooting Complex and on NWTF property, I acknowledge that shooting or vehicle use has inherent risks, hazards, and dangers that cannot be completely eliminated. **I UNDERSTAND THESE INCLUDE BUT ARE NOT LIMITED TO:** 1) The risk of handling firearms and being near other that have firearms in their possession. 2) The risk of personal injury and/or damage to personal property from shooting events, vehicle usage or physical activity. 3) The risk of personal injury from the physical requirements of shooting events. 4) The risk of possible ear damage from noise. 5) The risk of possible eye damage. 6) Exposure to lead dust and particles.

1) Eye and ear protection must be worn at all times when shooting or in a shooting area. 2) **DRUG AND ALCOHOL USE IS STRICTLY PROHIBITED. WE WILL NOT ALLOW ANYONE TO SHOOT THAT WE BELIEVE IS UNDER THE INFLUENCE OF ANY ALCOHOL OR DRUGS.** 3) **ALL FIREARMS MUST BE POINTED DOWN RANGE AT ALL TIMES** and never pointed higher than the target. 4) **DO NOT BRING A LOADED OR MALFUNCTIONING FIREARM OFF THE RANGE EVER.** If there is a problem, keep the muzzle pointed down range and notify staff. 5) Shooters under the age of 18 must be accompanied by a parent, guardian, coach or instructor. 6) ANY UNSAFE ACT, as defined by range staff, will result in immediate removal and possible revocation of right to use the facility. 7) I certify that I have adequate insurance to cover any injury or damage I may cause or suffer, or else I agree to personally bear the costs of such injury or damage. 8) **STAFF MEMBERS' DIRECTIONS MUST BE FOLLOWED AT ALL TIMES!**

Participant for himself/herself, executors and assigns, releases the NWTF and the Palmetto Shooting Complex, and its/their Agents, Employees, Partners, and Instructors from any and all liability for personal injury or property damage arising out of the use of the equipment or facilities of the NWTF or the Palmetto Shooting Complex.

I have fully and carefully read this liability release form understand its contents. I am aware that this is a release from liability and indemnification agreement and a contract between the Collective Entities and myself and that it imposes limitations to my legal rights. I sign it of my own free will. I certify that I will not operate any firearms or equipment with which I am not completely familiar. I acknowledge that this liability release is valid for one calendar year from the date below.
